COVID-19 Updates

- CDC recommends the 2024-2025 updated COVID-19 vaccines, expected to be available in Fall 2024.
- Everyone ages 6 months and older should receive an updated 2024-2025 COVID-19 vaccine to protect against serious illness from COVID-19.
- <u>Children aged 6 months-4 years</u> may need multiple doses of COVID-19 vaccines to be <u>up to date</u>, including at least 1 dose of updated COVID-19 vaccine.
- <u>People who are moderately or severely immunocompromised</u> may get additional doses of updated COVID-19 vaccine.
- People aged 65 years and older who received 1 dose of any updated 2023-2024 COVID-19 vaccine (Pfizer-BioNTech, Moderna or Novavax) should receive 1 additional dose of an updated COVID-19 vaccine at least 4 months after the previous updated dose.

COVID-19 & Flu Vaccinations

- In addition to the COVID-19 updated vaccine, the CDC recommends the updated 2024-2025 flu vaccine to protect against severe COVID-19 and flu this fall and winter.
- CDC encourages providers to begin their influenza vaccination planning efforts now and to vaccinate patients as indicated once 2024-2025 influenza vaccines become available.

Carry Naloxone, Save a Life

Naloxone, commonly known as **Narcan** or **Evizo**, is a prescription medicine and antidote that is used to reverse an opioid overdose. In the event a person stops breathing due to an overdose, a bystander can **safely and legally** use naloxone to help the person wake up and continue to breathe.

In New Jersey, anyone 14 years or older can obtain naloxone anonymously and at no cost at participating pharmacies across the state. This nation-leading program was created in 2023 through a partnership by the Department of Human Services and the New Jersey Board of Pharmacy and its Medicaid division to make this life-saving medication more readily accessible to the public amid an opioid overdose and addiction epidemic.

How to Respond to an Opioid Overdose

- 1. Identify Overdose & Check for Response by checking for signs of an opioid overdose such as being unresponsive to voice or touch, slow or irregular breathing, pale skin, purple lips and fingernails, very small pupils, faint heartbeat, limp arms and legs, inability to speak, and/or vomiting.
- 2. Call 9-1-1 to get the person immediate medical attention.
- 3. Administer Naloxone. If a person does NOT respond after a single dose, another dose may be given every 2-3 minutes until the person responds OR emergency medical help is received.
- 4. Start Rescue Breathing & Chest Compressions if the person is still not breathing or gasping for air.
- 5. Place person in the Recovery Position: put the person on their left side with their right leg and right arm crossed over their body. Stay with the person until help arrives.



Find Heating & Cooling Assistance

The Low Income Home Energy
Assistance Program (LIHEAP) is a
federally funded program designed
to help low-income families and
individuals meet home heating and
medically necessary cooling costs.

Applications and recertifications for the 2025 season open on <u>October 1st</u>, <u>2024</u>. To be considered eligible, the applicant household must be responsible for home heating and cooling costs and have a gross income that falls at or below 60% of the NJ State Median Income level.
