FEMA COVID-19 Funeral Assistance

FEMA is offering national assistance to families of people who have passed away from COVID-19. If you are a U.S. citizen, non-citizen national, or qualified non-citizen; the death occurred in the United States, including U.S. territories and the District of Columbia; the death was attributed to COVID-19; and you are responsible for the eligible funeral expenses incurred on or after January 20, 2020, you may be eligible for up to \$9,000 in assistance. Expenses may include funeral services, cremation, headstones, caskets or urns, and more. There is a specific application process and required documents for this program to be eligible. COVID-19 Vaccination Updates

COVID-19 vaccination guidelines have recently changed. The Moderna vaccine has been approved for children six months to five years of age and the Pfizer vaccine has been approved for children six months to four years of age. In addition, everyone ages five and older who have completed their primary series are eligible for a booster five months after completing their primary series. Therapeutics and Monoclonal Antibodies



There are plenty of COVID-19 treatments for eligible patients who have tested positive that can greatly reduce your chances of being hospitalized or dying from the disease. These treatments were purchased by the federal government and distributed to healthcare providers nationally, and range from monoclonal antibodies to oral antivirals. Both types of therapeutics have been authorized for emergency use. 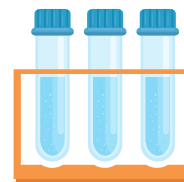
